What is the CLA?

The CLA presents and sponsors most of the social functions of Canadian Lakes. In 1975 a “Year Rounder's” Club was organized and in 1980 Articles of Incorporation were filed with the State of Michigan for the Canadian Lakes Association, Inc. (CLA) as a nonprofit organization of Canadian Lakes Property Owners. We worked with the Development Corp. until the property was turned over to the owners and since then have worked closely with the CLPOC.

Most CLA activities are organized and hosted by the CLA board, which consists of 12 members who plan and provide, with the help of our many community volunteers, the various social events throughout the year at little or no cost to members.

What is the CLPOC?

The Canadian Lakes Property Owners Corporation (CLPOC)) is the governing body of Canadian Lakes, handling all financial and infrastructure within our community. The CLPOC has nine board members who volunteer their time to serve the community. They hire a general manager who runs the day to day operations of the corporation with the guidance of the board.

CLA 2018 Member Referral Program
